PLEADINGS AND PARTICULARS

The Plaintiffs

1. The Plaintiffs join issue with the Defence to Amended Statement of Claim filed on 17 September 2015 (**Defence**) by the Defendant (**AET**) except insofar as it contains admissions.

Contingent Liability to repay not fulfilled prior to 10 June 2009

2. In answer to paragraph 42 of the Defence, the Plaintiffs say that:
 - (a) the Trust Deed provided that unless otherwise specified in the conditions of issue or any debenture, if requested by the debenture holder, the face value of a debenture would be repaid to the debenture holder within 30 days after the maturity date.

Particulars

Trust Deed, clause 2,3.2.

- (b) The conditions of the issue or the debentures to the Plaintiffs and each Group Member did not otherwise specify from what was provided for in (a) above.
- (c) By reason of the matters pleaded in (a) and (b) above, the liability of Provident Capital Limited (receivers and managers appointed) (in liquidation) ACN 082 735 573 (Provident) to repay the Plaintiffs and each Group Member the face value of their debentures within 30 days after their maturity date was contingent upon the Plaintiffs and each Group Member requesting Provident to do so;
- (d) The contingency for Provident to be liable to repay the Plaintiffs and each Group Member the face value of their debentures within 30 days after the maturity date was not fulfilled any time prior to 10 June 2009, as neither the Plaintiffs nor any Group Member had requested Provident to do so.

Particulars

Provident had paid or repaid the face value on all debentures that were requested to be repaid prior to 10 June 2009.

- (e) In the premises, the Plaintiffs and each Group Member has sustained no loss or damage at any time prior to 10 June 2009.

Loss not **reasonably** ascertainable prior to 10 June 2009

3. Alternatively, in further answer to paragraph 42 of the Defence, the Plaintiffs say that if they or any Group Member had sustained any loss or damage prior to 10 June 2009 (which is denied), such loss or damage was not reasonably ascertainable at any time prior to that date-

Particulars

- (a) Provident had met all of its obligations in relation to the repayment of the face value of any debenture that was requested to be repaid prior to 10 June 2009;
- (b) Provident's audited financial statements recorded positive net assets for each of the financial years ended 30 June 2009, 30 June 2008, 30 June 2007, 30 June 2006 and 30 June 2005.




