- 1 Contribution from each of the Cross-Defendants under ss 3(1)(c) and (2) of the Wrongs Act 1954 (Tas), or alternatively ss 5(1)(c) and (2) of the Law Reform (Miscellaneous Provisions) Act 1946 (NSW), or alternatively any other similar or equivalent provision of any other applicable legislation providing for contribution.
- 2 Further or alternatively, contribution from each of the Cross-Defendants in equity.
- 3 Interest up to judgment pursuant to s 100 of the *Civil Procedure Act 2005* (NSW).
- 4 Costs and interest upon costs paid prior to judgment.
- 5 Such further or other order as the Court thinks fit.
