A NATURE OF DISPUTE

- The Second Cross-Defendant, Gunns Limited (In Liquidation) (Receivers and Managers Appointed) agrees with the general description of the nature of the dispute.
- The Second Cross-Defendant disputes the Cross-Claimants allegations in the Fourth Cross-Claim Commercial List Statement as more fully set out below.

B ISSUES LIKELY TO ARISE

1 The Second Cross-Defendant agrees that the issues identified by the Cross-Claimant are likely to arise in the proceedings.

C SECOND CROSS DEFENDANT'S RESPONSES TO CONTENTIONS

- 1 As to paragraph 1(b), the Second Cross-Defendant:
 - (a) repeats against the Cross-Claimant the responses made by the Second Defendant in paragraphs 2-3, 14-52, 56-64, 68, 73-76, 81, 95-96 and 101-103 of section C of the CLR;
 - (b) admits the matters alleged in paragraph 9(b) of the Amended Commercial List Response of the Fourth Defendant;
 - (c) admits the matters alleged in paragraph 10(a) of the Amended Commercial List Response of the Fourth Defendant;
 - (d) refers to and repeats its responses to paragraphs 9(b) and 10(a) of the Amended Commercial List Response of the Fourth Defendant and otherwise denies the matters alleged in paragraph 85(b) of the Amended Commercial List Response of the Fourth Defendant.
- As to paragraph 2, the Second Cross-Defendant denies that the Cross-Claimant is entitled to the relief set out in the Cross-Summons dated 30 August 2018 against the Second Cross-Defendant.
