\*Schedule 1: Civil Procedure Amendment Fees Regulation 2017.NSW. Court fees are GST exempt. The Individual fee rate will apply to: liquidators commencing action on behalf of company in liquidation, Office of the Protective Commissioner of NSW, NSW Trustee & Guardian. Fee exempt bodies include NSW budget dependant agencies eg area health networks. The list of budget dependent agencies is available at NSW Treasury. This is an indicative list only and it maybe necessary to go to the Act that establishes the body to determine its status. Commissioner of Taxation (exercising powers under S263 of income tax assessment act 1936. And "exempt public authority" defined in s4 of the Corps Code.
