### TERMS OF ORDER MADE BY THE COURT

#### THE COURT ORDERS THAT:

#### Settlement Approval

- 1. Pursuant to sections 173 and 183 of the *Civil Procedure Act 2005 (NSW)* ("Act"), the settlement of the proceeding between the plaintiff and defendant be finally approved on the terms set out in the:
  - a. Deed of Settlement Executed by the parties that is exhibit BS7-1 to the affidavit of Ben Slade affirmed on 5 February 2016 ("Deed");
  - b. Settlement Distribution Scheme that is exhibit BS6-1 to the affidavit of Ben Slade affirmed on 30 July 2015 ("Scheme").
- 2. Pursuant to section 183 of the Act, Ben Slade be appointed as the Administrator of the Scheme.

## Late Registrants & further monies into the Reserve Fund

 Order 11 made on 31 July 2015 be varied so that the individuals described as "Late Registrants" in the affidavit of Ben Slade affirmed 5 February 2016 ("Late Registrants") are entitled to receive funds from the proposed settlement of this proceeding.

4. Pursuant to section 183 of the Act, the Late Registrants be deemed to have complied with clause 5.2(a) of the Scheme.

# Late determination that a 'known group member' was relevantly an adult

5. Order that paragraph 1 of the Third Further Amended Statement of Claim be amended as underlined below so as to read:

"The plaintiff brings this proceeding on his own behalf and on behalf of represented persons pursuant to Part 10 of the Civil Procedure Act 2005 (NSW) being:

- (a) Mr Tyson Kostic; and
- (b) \_\_\_persons (Group Members) who prior to 20 May 2014:
  - (i) were detained by a member of the New South Wales Police Force (**NSW Police Force**) for only a breach of a bail condition or bail conditions; and
  - (ii) the alleged breach of the bail condition or bail conditions related to an alleged offence or offences which were being or had been prosecuted in the Children's Court of New South Wales; and
  - (iii) at the time of the detention, were not then subject to the bail condition or bail conditions which were alleged to have been breached.

## (Collectively 'Group Members').

### Group members under a legal incapacity

- 6. Pursuant to section 77(3) of the Act, orders that:

## Reasonable Legal Costs

- 9. An amount of \$2,000,000 be approved as the reasonable costs and disbursements of the plaintiff in this proceeding and paid to Maurice Blackburn from the Reserve Fund.
- 10. The Public Interest Advocacy Centre be paid the interest earned on the Reserve Fund as a contribution towards its costs of assisting group members in the course of the administration of the settlement of the proceeding.

- 11. Order 5(b) made on 31 July 2015 be varied by changing the date to 4 September 2015.
- 12. Order 5(c) made on 31 July 2015 be varied by changing the date to 10 September 2015.
