## A NATURE OF DISPUTE

- The Second Cross-Defendant agrees with the general description of the nature of the dispute in the Sixth Cross-Claim Commercial List Cross-Claim Statement filed on 2 July 2021 (**Cross-Claim**) other than the reference to 'Mr Eugene Gay' in paragraph 3 should be 'Mr John Eugene Gay'.
- 2 The Second Cross-Defendant disputes the Eighth Defendant's allegations in the Cross-Claim as more fully set out below.

## B ISSUES LIKELY TO ARISE

The Second Cross-Defendant agrees that the issues identified by the Eighth Defendant in the Cross-Claim are likely to arise in the proceeding.

## C FOURTH CROSS-DEFENDANT'S RESPONSE TO THE CONTENTIONS

For the purposes of responding to the Cross-Claim only the Second Cross-Defendant says as follows.

## Allegations made by the Plaintiffs

- As to paragraph 1(a) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 4, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.
- As to paragraph 1(b) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 5, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.
- Further, the Second Cross-Defendant refers to and repeats paragraph 11 and 12 of section C of the CLR.
- As to paragraph 1(c) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 6, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.

- As to paragraph 1(d) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 7, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.
- As to paragraph 1(e) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 8, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.
- As to paragraph 1(f) of the Cross-Claim, the Second Cross-Defendant refers to and repeats as against the Eighth Defendant the responses made by the Fourth Defendant in paragraphs 10, 14-52C, 55A-64, 69, 73-75, 82-84, 90B-94A and 102-104 of section C of the CLR.
- 8 As to paragraph 2 of the Cross-Claim, the Second Cross-Defendant:
  - (a) denies each of the allegations in paragraph 2 of the Cross-Claim; and
  - (b) says that by reason of the matters in paragraphs 2 and 3 above, if(which is denied) the Eighth Defendant is entitled to contribution fromthe Second Cross-Defendant it is just and equitable that:
    - the Second Cross-Defendant be exempted from liability to make contribution having regard to the extent of Mr Gay's responsibility for the damage;
    - (ii) alternatively, the amount of contribution recoverable from the Second Cross-Defendant should be zero having regard to the extent of Mr Gay's responsibility for the damage.
- 9 As to paragraph 3 of the Cross-Claim, the Second Cross-Defendant:
  - (a) denies each of the allegations in paragraph 3 of the Cross-Claim; and
  - (b) says that by reason of the matters in paragraphs 2 and 3 above, if(which is denied) the Eighth Defendant is entitled to contribution fromthe Second Cross-Defendant it is just and equitable that:

- the Second Cross-Defendant be exempted from liability to make contribution having regard to the extent of Mr Gay's responsibility for the damage;
- (ii) alternatively, the amount of contribution recoverable from the Second Cross-Defendant should be zero having regard to the extent of Mr Gay's responsibility for the damage.

## 10 As to paragraph 4:

- (a) The Second Cross-Defendant admits that the Eighth Defendant claims as against each Cross-Defendant for the relief set out in the Cross Summons dated 1 July 2021;
- (b) refers to and repeats paragraphs 1 to 9 above; and
- (c) otherwise denies each of the allegations in paragraph 4.
