VERDICT ORDER OR DIRECTION:

1. The class action proceedings (case number: 2019/232749) are to be case managed together with proceedings number 2020/175890 and proceedings number 2019/ 64406.
2. All evidence served by the plaintiffs in the class action (case number: 2019/232749) is to be served on the parties in the other two sets of proceedings (proceeding number 2020/175890 and 2019/64406) and to the extent that leave is necessary for any party to rely on those documents in any set of proceedings, that leave is hereby given.
3. All three proceedings are stood over to 23 April 2021 at 10 am for a Zoom hearing, unless His Honour is informed (by email to his Honour's Associate) that the date is not required, by which time it is expected that all material served by an party in the class action proceedings will be served on the parties to the other proceedings, the plaintiffs in the class action will have served their proposed amendment Commercial List Statement and the parties in the Owners Corporation proceedings (proceedings 2020/175890) will be in a position to inform the Court as to when they will serve their evidence and the extent to which their position differs, if at all, from that put in the class action proceedings.
4. At that date the parties are to inform the Court as to their best estimates of the length of the hearings with a view the matters being fixed for hearing in the first quarter of 2022.
