- 4. By 4.00pm on:
- (a) 17 April 2020, the defendants file and serve any affidavit and written submissions in respect of the Settlement Approval Application; and
- (b) 22 April 2020, the Contradictor (to the extent that he wishes to object to the proposed settlement or any term of the Settlement Distribution Scheme) file and serve any written submissions in support of his objection.

- 5. On or before 27 March 2020 the plaintiff file any confidential affidavit and/or confidential submissions on which it intends to rely in respect of the plaintiff's Settlement Approval Application and in relation to which it intends to seek a confidentiality order.

- (a) provide to the Associate to the presiding judge the original and one copy of any such affidavit and/or submissions in an envelope marked with the details of the proceeding and a notation that it is a "Confidential [Affidavit or Submissions] for Purposes of the Settlement Approval Application not to be opened other than by order of the Court or a Judge"; and

(b) to serve copies of such material on the Contradictor.
