Fee exempt bodies include NSW budget dependent agencies. The list of budget dependent agencies is available at NSW Treasury. This is an indicative list only and it may be necessary to go to the Act that establishes the body to determine its status. Commissioner of Taxation (exercising powers under s353-15 Taxation Administration Act 1953. And 'exempt public authority' defined in s9 of the Corporations Act 2001. Check ABNs at abr.business.gov.au/Search/Advanced
- * Corporation fees apply to: Local Government, councils, companies Inc, Pty Ltd, cooperatives, medical funds, permanent trustees, universities, unincorporated associations, religious organisations, private schools, private hospitals, Local Area health networks, charities. Under clause 4(4) of the Civil Procedure Regulation 2017 an individual rate may be applied if income is less than \$200,000.00 per annum. Evidence must be provided & an application approved. Where there are multiple parties and one of the parties is a corporation then the corporation or organisation fee will apply. Sole traders are charged the individual rate.
- *In accordance with the Interpretation Act 1987, the definition of 'The Crown' does not extend to Commonwealth Crown or statutory bodies
