Amended Summons

- 1. The Plaintiffs be granted leave to file and serve:
- (a) an Amended Summons to correct the matters raised in the letter from the solicitors for the Plaintiffs to the solicitors for the Third Defendant dated 25 September 2019; and
- (b) an Amended Commercial List Statement (ACLS) to correct the matters raised paragraph 5 in the letter from the solicitors for the Plaintiffs to the solicitors for the Third Defendant dated 18 October 2019, and make any
- other corrections in respect of any other matters to which the defendants consent, prior to filing the ACLS.
- 2. By 6 March 2020, the Plaintiffs are to file the Amended Summons and Amended Commercial List Statement mentioned in order 1 above.
- 3. By 13 March 2020, the Third Defendant is to file and serve his Commercial List Response to the Amended Commercial List Statement.

Common fund order:

- 4. Orders 7 and 8 of the orders made by his Honour, Justice Hammerschlag on 8 November 2019 (8 November 2019 Orders), be set aside.
- 5. Any person who has given an undertaking to the Court pursuant to Order 8 of the 8 November 2019 Orders be released from such undertaking.
- 6. The orders made by his Honour Justice Hammerschlag on 15 August 2019 be varied nunc pro tunc such that Orders 2.1 and 2.2 of those orders be struck out.
- Evidence and discovery:
- 7. By 6 March 2020, the parties are to confer and endeavour to agree upon the form and scope of the disclosure process.
- 8. By 8 April 2020, the Plaintiffs are to:
- (a) serve any lay evidence upon which they intend to rely; and
- (b) serve a document identifying the nature of any expert evidence upon which they intend to rely.
- 9. The matter be listed for further directions on 24 April 2020.
- 10. Liberty to restore on 3 days' notice.
