## 2023/00124390-001 / Statement of Claim: Mark Fahey v ANGLICAN COMMUNITY SERVICES INVESTMENT HOLDINGS PTY LTD trading as Anglicare Sydney GARLING J MAKES THE FOLLOWING ORDERS:

- 1. Grant leave to the plaintiff to file a Further Amended Statement of Claim, providing that the Further Amended Statement of Claim is filed and served on or before 25.8.23.
- 2. Order the defendants to provide the plaintiff with a Request for Particulars, if so advised, by 1.9.23.
- 3. Order the plaintiff to respond to any Request for Particulars from the defendants by 20.10.23.
- 4. Order that before 29.9.23, the parties are to correspond and confer in order to reach agreement in relation to the production and exchange of documents including disclosure, security for costs and the proposed public notice and opt out notice.
- 5. Order that on or before 13.10.23, the plaintiff is to file and serve his draft opt out notice, draft orders with respect to the proposed manner and timing of the giving of the opt out notice, any information as to the anticipated costs of the opt out notice in the manner proposed, and a draft order as to the payment of costs of the publication of the draft opt out notice.
- 6. Order that the defendants are to file any Motion for security for costs together with all supporting affidavit evidence by 13.10.23.
- 7. Order that the plaintiff is to file and serve any evidence in reply relied upon in opposition to such order or orders by 10.11.23.
- 8. Order that any outline of submissions by the defendants in support of the orders for security for costs is to be filed and served by 24.11.23.
- 9. Order that any submissions opposing the orders for security for costs be filed and served by the plaintiff by 1.12.23.
- 10. Order the defendants to file their Defences by 17.11.23.
- 11. Order that any cross-claims are to be filed and served by 1.12.23.
- 12. List matter for directions before Garling J on 7.12.23.
- 13. Grant leave to the defendants to make returnable their Motions for security for costs before Garling J on 7.12.23.
- 14. Grant liberty to apply to restore the proceedings on reasonable notice.
- 15. Reserve all questions of costs.
